**Auditor's Report**

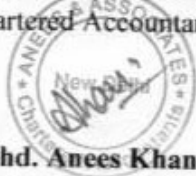

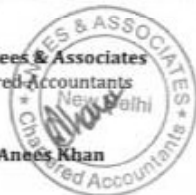

**A) ACCOUNTING POLICY**

1. The accounts are prepared on historical cost basis as a 'going concern'. Income and expenses are accounted for on cash basis following generally accepted accounting principles and practices and Accounting Standards issued by the Institute of Chartered Accountants of India for NPO's wherever applicable, except where otherwise stated.
2. Transactions in foreign currency are recorded at the rates prevailing on the date of transaction on the amount received net of bank charges.

**B) NOTES**

1. Previous Year's figures have been regrouped and rearranged to make them comparable, with the figures of the current year.
2. The Organization does not have any policy regarding the physical verification of fixed assets on yearly basis or half yearly basis.
3. Organization has received grant from Rural India Supporting Trust in Foreign Currency through the Prior Permission given as per FCRA Rules & Regulations.
4. Expenses on account of Grant for Hospital & Education and administration expenditure are generally incurred by the FCRA Fund.

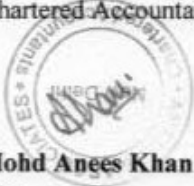
